5. **No Tender/bid is to be handed over** to any of our staff/ any other person.
6. Tenders/Quotations must be sent **sufficiently in advance** so that it reaches us on or before the due date and time. Quotation received after the due date & time cannot be considered.
7. The firm quoting for above mentioned items should be the authorized dealer/distributor for carrying out the SERVICES. The institute will not be responsible for any statutory compliance in respect of items and Services provided by the firm.

**The offer must comprise of the following failing which it will be treated as non-responsive hence rejected:**

1. **Price:** The basic price with break up for each item may be quoted in **Unit price**. IIMI will decide on the quantity required.
2. **Financial Bid** should be used for bid submission.
3. **Tender Processing Fee** : Nil
4. **Earnest money deposit** : Rs. 10,000/- (Rupees Ten Thousand only).
5. **Earnest Money Deposit (EMD / Bid Security (BS))** has to be submitted by bidders except those who are registered with
  - I.) **Central Purchase Organization (CPO) i.e. DGS & D.**
  - II.) **National Small Industries Corporation (NSIC).** However, this certificate should be for manufacturing of the item indented and not for selling items manufactured by other firms.
