## Scope of consultancy services

## <u> Section – I</u>

#### Introduction:

IIM Indore is one of the premier Management Institutes formed as part of the second generation of IIMs, established by the Government in 1996. The Institute is located on a picturesque hillock over looking Indore all around. The main Faculty & Academic blocks were designed by a leading Consultant of the country. The concept adopted and theming embossed for the main building is livid and vibrant.

The Institute is already having 04 nos. of Electrical Utility substations and number of infrastructures in terms of academic classrooms, faculty offices, student hostels and other management development centers. We are now looking forward to configurate them as a smart building in all its derivatives and make it a world class one with right ambience and green environment. The various facilities where an uplift and improvement in the electrical, electronics and mechanical proposed are given below.

#### Scope of Work:

The various locations where BMS/SCADA, HVAC, Electrical, electronics & Mechanical works proposed are mentioned below:

- 1. Redesigning / Up-gradation of the existing Electrical Utility substation-I, 33/11 KV and 11/0.433 KV Distribution system with 1600 KVA capacity and Power back up plan for the same.
- 2. Redesigning/Up gradation of existing Utility Substation –II with 11/0.433 KV substation and distribution system with 2500 KVA capacity and power back up plan for the same.
- 3. Redesigning/Up gradation of existing Utility Substation –III with 11/0.433 KV substation and distribution system with 1000 KVA capacity and power back up plan for the same.
- 4. Ring main system/Master control center design for electrical power back up of all four utility substations.
- 5. Exploring & Designing of rooftop Solar Photo voltaic system for internal, street lighting & hot water for all executive, faculty & staff residences.
- 6. Integration of all utility substations for remote monitoring and controlling through SCADA/BMS systems. Implementation of power management system (PMS) that will monitor the electrical system parameters, Report generation & SMS alert in case of any abnormality in the system for timely action.
- 7. Redesigning/up gradation of Existing HVAC systems. Automation and temperature control of HVAC system by using latest technology etc.
- 8. Survey & planning of installation of CCTV camera at various locations at IIM Indore as per CISF recommendations.
- 9. Planning for secure cable laying network through construction of RCC Cable trench at various locations.
- 10. Upgradation of EPABX system & installation of communication device at security watch towers.

11. Planning & designing of Public addressing systems for emergency communication.

- 12. Designing of Audio, Video, Conference systems with catwalk services above false ceiling at new auditorium in sports complex.
- 13. Firefighting/smoke detector systems at various building & auditoriums.
- 14. Energy audit by competent energy auditor.
- 15. Design of single line diagram (SLD) covering entire electrical system with all requisite protection.
- 16. Formulation of equipment layout & associated schematic diagram.
- 17. Upgradation Power supply system consisting of incomer supply, distribution and cabling systems including breakers, transformers, capacitor bank, Neutral grounding systems, bus bar, power control panel and street light poles with connecting cables.
- 18. Designing of Sensitive Lightning, Earthing & fire protection system for various building, utilities, library & auditorium etc.
- 19. Planning for Access control system at various offices in academic zone.
- 20. Feasibility study for additional 33 KV HT line with back up support as a stand by source.
- 21. Planning & implementing energy saving illumination design by LED lights at street light, watchtowers & high mast towers.
- 22. Evaluation & Design of phase out plan of electrical & HVAC system adoption of state of art energy saving systems.
- 23. Any other similar features to integrate into an IBMS and reduce operative cost.

## Eligibility Criteria for Pre-qualification

## <u> Section – II</u>

- 1. The Consultant or Lead Consultant shall have more than 5 years experience in the field of Consultancy of the BMS/SCADA, Electrical, Substations works (upto 33kv), Audio-visual/Electronics, HVAC, Renewable energy, energy efficiency and green building sector, Installation of CCTVs, access control & Fire detection alarm & control system.(Form C)
- 2. The consultant must have completed at least 03 assignments in the area mentioned above.
- 3. They shall submit self attested copies of all certificates and registration, which are required to substantiate their eligibility.
- 4. It is desirable that a minimum of 50% of the key professional staff employed by the firm shall be permanent employees of the firm.
- Curriculum Vitae of only key persons / lead person are to be submitted in respect of Electrical, SCADA/BMS, CCTV, HVAC, EPABX, Electronics & mechanical works etc., if such professional are employed by the Consultant or Firm.
- 6. The participating Consultancy firm should have valid Service Tax Number / PAN / WCT / TAN / EPF / VAT etc. Attested copy to be enclosed.
- 7. Copies of registration / empanelling with other organization if any, may be attached with complete mailing address.
- 8. If any misleading or false representation or deliberately suppressed the information in the application will lead to disqualification.
- 9. Completion certificate from the client should be submitted as proof of having done similar work.
- 10. Firm's shortlisted based on pre-qualification criteria will be called upon to present the scheme.
- 11. Further short listing will be done based on the scoring in presentation and their financial bid will be opened.

## Selection Procedure:

## <u> Section – III</u>

The selection of consultants for providing consultancy services for modernization up-gradation & automation of electrical power supply system and electronics & mechanical works will be processed under following two steps:

### Step 1:

- The applications / expression of interest received against this notification will be scrutinized and a short list will be prepared.
- The short listed consultants will be called upon to participate in a design competition among them.

### Step 2:

- A duly constituted Jury / Board of Assessors will select one or more designs based on the QCBS (Quality and cost based selection) of design concept.
- Details of the procedure of presentation of design concept on a competitive basis, and design brief will be dispatched to the short listed consultancy firms separately.

### Execution Mode:

The work as a composite one will be tendered for execution. All eligible parties/ contractors will be able to participate on the tender process.

1. Consultancy firm having minimum of 5 years' experience fulfilling the eligibility criteria enumerated in Section – II, shall participate in the selection process.

Application and envelopes should be super scribed with "Tender for providing consultancy services for modernization, up-gradation & automation of electrical power supply system and building automation system."

- 2. A Committee constituted by the Director, IIM Indore, will evaluate the eligibility / pre-qualification documents submitted by the Consultants and will prepare a short list. Decision of the Committee shall be final and binding to all.
- 3. There shall be a concept design presentation by the short listed Consultants. For design presentation purpose, Utility-II substation, HVAC system, New Auditorium & Main academic block/ buildings will be identified to integrate SCADA/BMS, CCTV & automation system. All short listed Consultants will have to come up with their innovative for up gradation/new design of these four areas.

- 4. Details of client requirement and modus of competition, date and time etc., will be intimated individually to each short listed Consultant.
- 5. Mere listing in the short list does not confer any right on any of the parties to receive invitation to participate at a later date.
- 6. Consultants selected to make presentation of concept design is expected to possess all state of art software related to 3D design / simulation/AutoCAD/ETAP and shall be able to present `walk through' showing all the internal / external features based on the nature & scope of work.
- 7. Separate sheet may be attached for furnishing details or credentials.
- 8. IIM Indore may call for additional information if necessary in support of their eligibility.
- 9. A committee to be constituted by Director IIM Indore will evaluate all the proposals based on the information submitted and subject to fulfilling the conditions as mentioned for short listing the firms for second stage bidding process.
- 10. All the documents submitted shall be signed by the authorized signatory and stamped.
- 11. Application received will not be acknowledged nor will late application be accepted.
- 12. If the applicant is a joint venture consortium, they must submit an affidavit signed by all the members of the participating organization and attested by a notary.
- 13. The short-listed Consultants / firm shall not modify the existing status quo during the tenancy of engagement with IIM Indore without prior approval of IIM Indore.
- 14. Short listed Consultant shall be invited to take part in the design presentation as and when informed of. If they do not participate in the process, they will be liable to be removed from the approved list.
- 15. There will be a Board of Assessors to adjudicate the design presentation and expert from the field of Consultants and other professions, will constitute the Board.
- 16. IIM Indore is not liable to furnish any information or give any reasons for accepting / rejecting or the award of marks at any stage of evaluation and related to any part of selection process.
- 17. Details of eligibility criteria, that shall be followed for short listing and the marking system is given at Annexure IV.
- 18. The Institute reserves the right to issue amendments, additions, and deletions etc at any stage of the selection process, which shall be binding on all parties.
