17. Overhead Charges: The quoted price (final offer) must be F.O.R. - IIM Indore, Indore including all overheads such as Packing, Forwarding, Loading/Unloading, Transporting, Postage/Courier, Octroi, Freight, Insurance etc.

18. Additional Charges if any, for Installation, Packing-Unpacking, Loading/Unloading, erection, Commissioning, Inspection, Certification, Extended Warranty any other charge(s) must be included in the quoted amount.

19. Discounts: The bidder need to mention clearly the exact figure/Percentage of discount offered, if any.

20. Validity of the bid: The validity period of the offer should be clearly specified. It should be at least for 90 (Ninety) days from the last date of submission of tenders.

21. Completion Schedule: The work should be completed in all respect within 90 days from the date of placing the order.

23. Receipt of Goods: The items mentioned in the schedule should be delivered at appropriate place in Good condition and as per required specification. The Items would be weighed, counted and measured, if required to confirm the accuracy.

24. Terms of Acceptance: The items will be treated Accepted only after Inspection for Features and Functions. This includes delivery, installation & commissioning, Inspection, demonstration, schedule etc.

25. Specification and Make: Tender should confirm the exact specification and make, Model, if any shown in the tender against Sl. No. of the item.

26. The competent authority shall have power (i) to make alteration in, omissions from, additions to, or substitutions for the original specifications, drawings, designs and instructions that may appear to him to be necessary or advisable during the progress of the work, and (ii) to omit a part of the works in case of non-availability of a portion of the site or for any other reasons and the contractor shall be bound to carry out the works in accordance with any instructions given to him in writing and such alterations, omissions, additions or substitutions shall form part of the contract as if originally provided therein and any altered, additional or substituted work which the contractor may be directed to do in the manner specified above as part of the works, shall be carried out by the contractor on the same conditions in all respects including price on which he agreed to do the main work except as hereafter provided.
27. Deviation: Deviation means deviation in quantities of items, i.e. where there is increase or decrease in the quantities of items of work in the agreement. The competent authority shall have power to make deviation up to 50% in the quantities and the contractor shall execute the positive deviated work as per the rate quoted by the bidder in the tender documents, and shall have no claim for any payment on account of such deviations and variations in quantity of any item(s) or component(s) of the work.
28. The successful bidder has to take Contractors all risk policy of the awarded value valid for the work period.
29. Payment: Full payment within 30 working days from the date of final satisfactory completion of the work and submission of the bills.
30. Guarantee/ Warranty: The item should be guaranteed on site (in situ) against any defect for a period of one year. The Contractor should guarantee that the work executed by him will render the item of work completely free of defects, faulty material and defective finish for one year to be reckoned from the date after the successful commissioning of the contract. Provided that the contractor will not be responsible for damage caused by misuse or alteration and for such purpose:
- (a) Misuse shall mean any operation which will damage the structure like chopping and things of the same nature which might cause damage.
- (b) Alteration shall mean construction of an additional section or a part of the same or construction adjoining to existing structure.
- (c) The decision of the IIM Indore with regard to this shall be final.
- During this period of guarantee the contractor shall make good all defects to the satisfaction of the IIM Indore at his cost, and shall commence the work for such rectification within seven days from the date of issue of the notice from the IIM Indore calling upon him to rectify the defects, failing which the work shall be got done by the IIM Indore by some other contractor at the GUARANTOR'S cost and risk. The decision of the IIM Indore as to the cost, payable by the contractor shall be final and binding.
31. In case any part or whole of the item is found to be defective and is found to be not upto mark, then the same will have to be replaced/repared free of cost at our premises immediately at the own cost and risk of the contractor.
32. Liquidated Damages: As Time is the essence of this order, the schedule of completion should be strictly adhered to, otherwise the implementation in full or in part will not be accepted and penalty for late delivery of contract will be imposed @ 10% per fortnight of the total

value of work order & beyond 10% subject to approval of Director IIMI. In case of delay in supply, Installation, commission, demonstration, Inspection, Certification etc. also the same rate of penalty shall be leviable. The computation for LD will be made on per day basis @ proportionate to the charges mentioned above.

33. Cancellation: IIM- Indore reserves the right to accept or reject or cancel any or all enquiries or tenders at any stage without assigning any reason thereof.
34. In case of cancellation of order due to Non-compliance of the Terms and Conditions and Breach of the Contract, No compensation will be paid towards progress of order/procurement.
35. For any dispute, the place of jurisdiction shall be Indore, India only & decision of Director, IIM Indore will be final.
36. The specifications, Terms & Conditions, other regulations which are not herein mentioned will be guided by relevant CPWD / BIS /Other Central Govt. norms applicable for IIM Indore & the decision in this regard will be guided by the decision of the respective authority of IIM Indore which shall be final and binding to the contractor.
37. The General Conditions of Contract, Special conditions of contract, Safety Code, Model Rules for the protection of health and other arrangements for workers, Specifications, documentation etc. will be guided by CPWD's regulations to the extent applicable to IIM Indore.
