applications are invited. The works completed up to previous day of last date of submission of tenders shall also be considered.

One similar completed work, costing not less than the amount equal to 2.34,112/-

OR

Two similar completed works, costing not less than the amount equal to 1,75,584/-

OR

Three similar completed works costing not less than the amount equal to 1,17,056/-,

Similar work shall mean: Civil Works.
