a. Watch and ward of the stores and their safe custody shall be the responsibility of the contractor till the final taking over of the installation by the IIM Indore.

31. Proper safety will be exercised during the work and all the personnel protective equipment and tools like helmets, gloves, safety belts, shoes etc. will be provided by the contractor during the work at his own cost.

32. Contractor will ensure proper cleaning of site and hygiene during the work on regular basis.

33. In case of any damage to the property of IIMI / site of work by workers/personnel of contractor, the contractor will be solely responsible and appropriate damage cost along with penalty will be recovered from the contractor's bill/payment/SD etc.

34. The contractor should make his own arrangement to work properly under all climatic conditions without affecting the quality and speed of work. The safety of all the materials used in executing the job will also be the responsibility of the contractor.

35. All legal and other statutory responsibilities regarding securities of materials, labour, payments, accident, insurance and lawsuits during the work will be solely borne by contracting agency and IIM Indore shall not be responsible in any manner whatsoever. The contracting
