#### **ADDENDUM-01**

#### Section - 8: General Terms and Conditions

## Clause no. 14: Tender Fee and Earnest Money Deposit Details:

- a. Tender fee of Rs. 500/- (Rupees Five Hundred only) inclusive of all taxes (applicable to all bidders) should be submitted through NEFT or RTGS or Bank Transfer or Direct Credit in favor of Indian Institute of Management Indore.

Micro and Small Enterprises (MSEs) firms as defined in MSE Procurement Policy issued by Department of Micro, Small and Medium Enterprises (MSME) or the firms registered with the Central Purchase Organisation or the concerned Ministry or Department or Startups as recognized by Department of Industrial Policy & Promotion (DIPP) for all these Services/ Items only, are exempted from Tender Fee and EMD. However, they have to enclose valid self-attested registration certificate(s) along with the Annexure-II of the tender documents.
- d. The bidders who seeks exemption from EMD as per clause no. c above, if they withdraw or modify their bids during the period of validity, or if they are awarded the contract and they fail to sign the contract, or to submit a performance security before the deadline defined in the request for bids document, they will be suspended for the period of three years or as decided by the competent authority from being eligible to submit bids for contracts with the entity that invited the bids.
- e. EMD is to remain valid for a period of forty-five days beyond the final bid validity period.
- f. EMD of all unsuccessful bidders (if any) will be returned after finalization of the tender. EMD of the successful bidder will be returned only after receipt of Security Deposit towards Performance Guarantee.
- g. In case of a successful tenderer, the EMD (if any) other than Bank Guarantee, may be adjusted towards the Performance Security deposit on request.

- h. The amount of EMD (if any) is liable to be forfeited, if the tenderer withdraws/alters the bid after submission of the tender or after the acceptance of the offer and fails to remit the Performance Security Deposit.
- i. No interest will be paid on the EMD (if any) / Performance Security deposited / remitted.
